ASEAN CHARTERED PROFESSIONAL ENGINEER (ACPE) EXCELLENCE AWARD 2024

The ASEAN Chartered Professional Engineer (ACPE) Excellence Award is given to ACPEs who has distinguished themselves nationally or internationally by attaining high standards in professional practice, made significant contributions to the engineering profession, entrepreneurship and community service in Singapore/ASEAN. The award recipient would serve as a role model to members of the profession and inspire both present and future engineers to achieve excellence in engineering, expand their engineering activities in ASEAN, and contribute to the profession and society in Singapore, ASEAN and the world.

Criteria Of Award

2 As a distinguished member of the profession, a nominee's achievements in professional engineering should cover one or more of the following areas:

a) Leadership and Management

Nominee who is a distinguished member of the engineering profession and a respected leader who has led and direct enterprises (including new companies) and engineering projects that achieved engineering excellence.

b) Service to the Engineering Profession at the National/ASEAN level

Nominee has achieved excellence in the practice of engineering and entrepreneurship in Singapore/ASEAN where innovative application of technology and engineering knowledge has brought advances in productivity, better engineering design and products and benefits to the industry. He/she has contributed to the engineering profession in teaching, research, service to professional institutions and organisations in Singapore, ASEAN and internationally.

c) Environmental Sustainability, Health and Safety

Nominee has adopted and implemented engineering design and projects that has a positive impact on Environmental Sustainability, Health and Safety. Nominee has contributed to public education, implementation of regulations, standards, guidelines and policies that lead to advancement in Environmental Sustainability, Health and Safety.

d) Service to Society and Community

Nominee's service to society and the community in Singapore or internationally. Such involvement may or may not be related to engineering and may include participation in education, volunteer work in the community, charitable organizations, participation in commissions, boards, task groups, etc.

e) <u>Publications, Intellectual Property and Engineering Education</u>
Nominee has made contributions to the profession through publications, research papers, intellectual property, presentations at national and international conferences.

Award Committee

3 The Board will set up an Award Committee comprising 5 Board members. All nominees will be assessed by the Award Committee who will determine its own procedures for assessing the nominees. The Award Committee will submit its assessments and recommendations to the Board for consideration and final approval.

General Eligibility

- 4 All ACPEs in good standing, registered with PEB in any one of the branches, involved either in the private or public sector, with the exception of serving members of the Board, are eligible for nomination to receive the ACPE Excellence Award.
- 5 One or more awards may be presented. However, no award will be given if there is no suitable recipient for the award.

Nomination Procedures and Time Frame

- A nomination may be made by any professional engineer who is familiar with the candidate by virtue of their positions and knowledge of the candidate. Selfnomination is not allowed. All nominations must be submitted using the official form provided.
- 7 The nominator is required to prepare and submit the nomination comprising:
 - a) a summary nomination of the nominee (Summary Nomination form downloadable from PEB website); and
 - b) a detailed submission (must not exceed 20 pages in total). Pages exceeding the 20-page limit will not be reviewed or considered in the evaluation process. It is important that the nominee's achievements be highlighted within the maximum 20 pages of the detailed submission.
- The closing date for submitting the nomination is 15 Aug 2024 (extended to 23 Aug 2024).

Selection Process

- 10 Written acknowledgements will be sent after a nomination package has been received.
- The Award Committee will review all nominations carefully. Each nomination will be rated and ranked with all other nominations based on the award criteria. Please ensure that the nomination demonstrates contributions in the selection criteria of the award. Once the Award Committee has made its assessment and selection, a recommendation will be made to the Board. The recommendation and subsequent decision will remain confidential until the chosen award recipient is notified by the President, Professional Engineers Board.
- Following the notification of the successful nomination, it is anticipated that the nominating team and the award recipient will endeavour to attend the presentation ceremony.
- 13 The award recipient will be expected to work with PEB and undertake initiatives for the promotion and development of professional engineering.
